 - i. Whitney: Email from Delaney about the proposed document. Have allocations discuss the proposed changes. Discuss the roles of the committee
 - ii. Mo: At the end of the semester, we should review the expenditures in order to cater towards improving the committee. Helpful to look about our expenditures every semester
 - iii. Whitney: Do we want a semester report in order to review expenditures? E.g. the checks paid out, .
 - iv. Bailey: I think that would be really helpful
 - v. Whitney: Discussion on the Allocations Committee attendance and how many senators need to sit on the committee going into the Summer.
 - vi. Tiffany: I think that would be really helpful to have at least 5 senators always sitting on the committee to fully review requests

- vii. Mo: It's important to have returner senators sit on the committee. Maybe add that a voting senator needs to be a returning senator
- viii. Bailey: I think that would be really helpful to know if such situations have happened in the past.
- ix. Tiffany: Do we want to add that to the document?
- x. Mo: Yeah. Kayla mentioned we want to have a higher quorum of 3 senators plus the chair.
- xi. Tiffany: Yeah, I think that would be really helpful and a bit easier to meet quorum if we always have 5 senators sitting on the committee.
- xii. Whitney: Just to clarify, we want to have 5+ senators of which 1 is a student orgs senator and 1 being a returning senator (if possible)?
- xiii. Whitney: Discussion on if Allocations Meeting should be open to the student body. In order for students to see how our meetings are run, but non-mmebers of the committee are unable to vote.
- xiv. Mo: Totally agree that the meetings should be open to the student body
- xv. Whitney: Article 6 (Requirements) about organization compliance with the university policy. Remove if Students are in good academic standing with the university, since it isn't really checked. What do we do if an meeting that is being put on by non-undergraduate students?
- xvi. Mo: Good point. Verbiage on how will fund it up to the next academic year, since the events being planned by the student (at the time of being of being an undergraduate?)
- xvii. Tiffany: I agree with that, since Career and Graduate applicant's test dates are often in the summer after graduation.
- xviii. Whitney: So far, we have been pretty strict with this, but we can extend the deadline to the end of Summer.
 - xix. Whitney: Dean Price is open to expanding the Academic Orgs range to allow for Academic Conferences and Career and Graduate tests.
 - xx. Tiffany: If this does get passed, would the money for Career and Graduate go somewhere else since Academic Orgs line is taking care of it now?
- xxi. Whitney: If it's passed, I recommend for it to go back to the Student Organizations fund.
- xxii. Whitney: Discussion around general club meetings. Do we want to have a dollar amount or how many meetings we want to cap at? (General Club Meetings)

Whitney: Lists of General Issues: 1) Events for Profit (would the organization pay SGA back if profit was made, if not, then a meeting would need to be held) Should SGA be getting part of the profits? 2) Appeals Process (Denials or Partial Funding need to be sent out with reason with the appeal process.) If there wasn't substantial information submitted, it'll go back to Allocations. If not, it'll go to an adhoc committee consisting of the chair, director of finance, and director of justice. Who will review the requests is up for debate. 3) Infractions (not much that we've dealt with recently). 4) Items funded storage/ownership (Who owns the SGA funded items) 5) Items and events for profit (expecting to be paid back)
